CONTRACT FOR WEBSITE DESIGN



General Information

Thank you for choosing Totally CG to design your Website. Below you will find the details of your Contract. Please feel free to contact me with any questions. Also find attached the pricing guidelines along with a worksheet for you to supply the details for your Website. Details can be your color scheme, theme, pictures of inspiration, stock images, addresses of websites you would like to emulate, etc..

During our first meeting the goal is to develop an outline of what you envision as your Website. After the consultation please read, sign and return the contract so we can begin the designing process! Please note you will receive a copy of this contract for your records as well.

^{***}Domain Names: If you currently have a Domain Name registered you can opt to keep it with the provider you signed up with or transfer it to the site your website will be hosted with.

If you choose to keep your Domain Name with the original registrar your cost will be the agreed upon rate for that company.

If you choose to transfer it to the hosting site your 1st year for the Domain Name will be Free. The cost to renew your Domain Name with the provided hosting site is \$16.00/year. This will remain the cost barring the hosting site changing their renewal policies and is out of the control of Totally CG.

***Design Fee: The prices for hosting are the base prices for the company we use to host your website. We do not upcharge on these prices. Therefore, we do charge a Design Fee for our work. Our base price for simple website designs is \$250. For more advanced websites we base our prices on complexity. For example, the more pages and details for each page the higher the Design Fee. Please note these prices are 100% negotiable. We are willing to work with your budget as much as possible

***Website Maintenance: If you would like us to continuously maintain your Website we would love to help! Our Retainer Fee is \$25.00/month for simple updates to your Website. For more in-depth changes a negotiated fee will be discussed before work is provided. If you would like to maintain your Website on your own we will make sure to transfer the login information to your email account and provide you with a temporary password to be changed upon your 1st login.

Payments

We accept three forms of payment for your convenience; Bank Check, Money Order & Credit Card. Please select which form of payment you prefer in the Client Information section of this contract. We request that 50% of the Design Fee be paid upon delivery of the 1st Milestone, 25% paid with delivery of the 2nd Milestone and the remaining 25% with the final delivery. As for the Hosting Fees, these must be paid in full on the date you would like your Website to officially launch. If you choose a Month-to-Month payment plan please provide the credit card information you would like charged each month with a Credit Card Authorization Form to be provided at time of final delivery.

Refunds

Please express all design requests and concerns during the agreed upon timeline to ensure everything is addressed before final delivery.

Please review carefully before approving. If we make a mistake after your design approval and delivery we will quickly correct your site and publish the adjustment. If you make a mistake or need changes after design approval and delivery, please let us know and we will be happy to help you correct the mistake at a reduced charge.

Once a payment or deposit is made, it is non-refundable. If a project is cancelled or postponed, all monies paid are retained by Totally CG and if applicable, a fee for all work completed beyond what was already paid for shall be paid by the client. Totally CG reserves the right disable and/or terminate a user's account if a user is found in violation of these terms. Accounts terminated due to policy violations will not be refunded.

Putting Link to Totally CG in the footer and Adding your site to Totally CG's Portfolio
